Workforce Australia



Community Training and Employment Initiatives

Five Bridges offers a range of training programs designed to equip community members with the skills and knowledge needed to gain employment opportunities. We offer a range of programs under the Qld Government's Skilling Queenslanders for Work Initiative in hospitality & food processing, community care, business, horticulture, driving operations and beauty industries across South East and Central Qld.

We also offer First Nations specific programs in Security, Construction and Community Services.

Community Justice Group Programs

Working closely with the Community Justice Groups of Ipswich, Brisbane and Sunshine Coast, Five Bridges provides essential support and services to Aboriginal and Torres Strait Islander victims and offenders within the criminal justice system.

620 people supported

The Community Justice Group's role is to support Indigenous victims and offenders at all stages of the legal process. We support diversionary processes (such as encouraging offenders to engage with the Murri Court) and develop networks with other community organisations to ensure that issues impacting on Indigenous communities are addressed.

Indigenous Alcohol Support Program

The Five Bridges Alcohol Support Program aims to educate and empower our community to ditch the booze, or at least learn to consume alcohol responsibly.

We don't shame participants. We're here to assist participants to live happier, healthier lives through providing the knowledge and tools to make informed decisions.

State Penalties Enforcement Australia (SPER)

Five Bridges is partnered with RTOs to support eligible Australians experience personal hardship to solve their super debt by completing an eligible course.

Ipswich Residential Program

We support First Nations people exiting the justice system through a supported accommodation program. Through this program we assist individuals with getting back on their feet after incarceration.

Murri Sisters Mobile Domestic Violence Service

We provide services for our Aboriginal and Torres Strait Islander women and children who are experiencing Domestic and Family Violence and associated factors that are linked to homelessness.
